- **Handling Complaints and Difficult Situations:** One of the most vital SOPs. It should empower the front desk agent to listen actively, apologize sincerely (without necessarily admitting fault), and offer solutions within a predefined "compensation" framework. The goal is to solve the problem immediately and prevent a negative review.
- **Night Audit:** A precise, step-by-step process for balancing

the day's financial transactions, posting room charges, and preparing reports for the management team. Accuracy is paramount here.

Housekeeping SOPs: The Language of Cleanliness and Comfort

Housekeeping is the largest department in most hotels and has the most direct impact on guest comfort. Its SOPs are among the most detailed.

- **Room Cleaning Protocol:** A precise routine for entering a guest room, cleaning from top to bottom and left to right. This includes exactly how to make a bed (including folds and tucks), how to clean a shower (specific order of glass, tile, faucet), and how to dust surfaces. A checklist is almost always used.

- **Turn-Down Service:** For hotels offering this premium service, a detailed SOP covers everything from arranging slippers to dimming lights, adjusting the thermostat, and leaving a small treat or an information card.
- **Public Area (Lobby, Restrooms, Corridors) Cleaning:** A schedule and protocol for ensuring high-traffic areas remain spotless throughout the day. This includes frequent touch-point cleaning of elevator buttons, door handles, and reception counters.

Food & Beverage (F&B) SOPs: Where Service Meets Safety

The F&B department is governed by both service standards and stringent health codes. Its SOPs are critical for both guest delight and legal compliance.

- **Table Setting and Service Sequence:** A standard for how tables are to be set (exact placement of silverware, glassware, napkins) and the sequence of service (taking orders, serving appetizers, clearing plates, serving entrees, etc.).
- **Order Taking and Point of Sale (POS) Procedures:** How to approach a table, take orders accurately, enter

them into the system, and communicate dietary restrictions to the kitchen.

- **Kitchen Preparation and Safety (HACCP):** These are non-negotiable. SOPs cover proper food storage temperatures, preparation guidelines, cooking temperatures, handwashing protocols, and cleaning schedules to prevent contamination and foodborne illness.
- **In-Room Dining:** A specific SOP for taking orders, preparing trays, delivering them promptly with the correct setup (condiments, napkins, cutlery), and the timeline for picking up used trays.
- **Bar Service:** Standardized drink recipes (ensuring consistent taste), glassware selection, responsible alcohol service (checking IDs), and cash handling.

Engineering and Maintenance SOPs: Keeping the Lights On

This department's work is often invisible until something breaks. Good SOPs prevent that break from happening and ensure a fast response when it does.

- **Preventive Maintenance (PM) Schedules:** A detailed calendar for inspecting and servicing key equipment like HVAC units, boilers, elevators, pool pumps, and fire safety
