# Reading and Interpreting Parking Signs

## Metered Parking: Paying Correctly and

## Avoiding Overpay

Metered parking in D.C. has evolved with technology. Pay-by-plate systems mean you pay for your license plate number, not a space. Key points to remember:

- Always input your correct plate number in ParkMobile or at the kiosk. A typo can result in a ticket even if you paid.
- Time limits still apply. You cannot "feed the meter" beyond the posted maximum (usually 2 or 4 hours).
- If the meter or app is broken,

you must still display payment or find alternative parking. The City does not waive tickets for malfunctioning equipment unless reported.

- Enforcement officers use license plate readers (LPRs) to scan all parked vehicles. They instantly know if you have paid, if your time expired, or if you have outstanding violations.

**Study tip:** Download ParkMobile and memorize your plate number. Set reminders for when your session ends, but remember the time limit rule.

## 4. Rush Hour and Street Cleaning Rules

Hearings (OAH).

**Important:** Pay the ticket before the deadline if you are unsure about winning, to avoid late fees. You can still appeal after paying.

# Enforcement Officers

DPW parking enforcement officers (PEOs) are human, but they follow strict protocols. They patrol on foot, in vehicles, and by bike. They use handheld devices that connect to the city's database. They typically focus on:

- Blocks with known violations (e.g., near schools, hospitals, popular restaurants).
- Vehicles with expired tags, missing license plates, or obvious damage.
- Areas where

complaints have been filed.

- Read blocks (fire hydrants, bus stops) are enforced immediately.
