## KEY CATEGORIES OF ARMY AWARDS

helps to understand the different types of awards it governs. The Army breaks down its decorations into several distinct categories, each with its own set of rules and criteria.

## Personal Decorations

These are awards given to an individual for specific acts of heroism, valor, or meritorious service. They range from the highest award for valor to recognition for exceptional service over a period of time. The regulation meticulously defines the degree of heroism required for each level.

- **Medal of Honor:** The highest

award for conspicuous gallantry and intrepidity at the risk of life above and beyond the call of duty.

- **Distinguished Service Cross:** Awarded for extraordinary heroism in combat, second only to the Medal of Honor.
- **Silver Star:** Awarded for gallantry in action against an enemy of the United States.
- **Legion of Merit:** Awarded for exceptionally meritorious conduct in the performance of outstanding services and achievements.
- **Bronze Star Medal:** Awarded for heroic or meritorious achievement or service in a combat zone.
- **Purple Heart:** Awarded to any member of the Armed Forces who is wounded or killed in action.

## Service Medals and Campaign Ribbons

Unlike personal decorations, service medals are typically awarded to all participants of a specific operation or period of service. The regulation lists every authorized campaign and the criteria for qualifying. Examples include the National Defense Service Medal, the Afghanistan Campaign Medal, and the Global War on Terrorism Expeditionary Medal. These awards signify a Soldier's participation in a significant military event.

# Good Conduct Medal

This award recognizes enlisted Soldiers who complete a specified period of honorable service. The **US Army Awards and Decorations Regulation** clearly defines the standards for character and efficiency that must be met. It is a testament to a Soldier's discipline and reliability. The Army Good Conduct Medal is typically awarded for three years of continuous active service, though the period is shorter for wartime service or first-term Soldiers.

# Unit Awards

These are awarded to an entire unit for collective heroism or exceptional service. When a Soldier serves as a member of that unit during the period of recognition, they are authorized to wear the unit award permanently. Common unit awards include the Presidential Unit Citation, the Valorous Unit Award, and the Meritorious Unit Commendation. The regulation specifies how these citations are annotated on a Soldier's records and worn on the uniform.

## THE ORDER OF PRECEDENCE: WEARING AWARDS CORRECTLY

---

One of the most critical aspects covered by the **US Army Awards and**

**Decorations Regulation** is the order of precedence. This refers to the specific sequence in which ribbons and medals are worn on the Army Service Uniform (ASU) or the Army Combat Uniform (ACU). Wearing them incorrectly is considered a breach of uniform discipline.

The order of precedence is not arbitrary. It is based on the relative importance of the award. Personal decorations for heroism are worn before personal decorations for service, which are worn before campaign medals. The regulation provides a chart that lists every authorized ribbon and its precise position. ## How to Read the Order of Precedence

The highest-ranking ribbon is worn at the top left of the rack (the wearer's right). The sequence then reads left to right, top to bottom. The regulation dictates that no ribbon may be worn unless it is authorized. If a Soldier is unsure about the placement of a specific ribbon, they are expected to consult AR 600-8-22 for clarity.

## THE NOMINATION AND

### APPROVAL PROCESS

Receiving an award is rarely automatic. The regulation outlines a strict protocol for initiating, processing, and approving award recommendations. This process is designed to ensure fairness and accuracy.

1. **Initiation:** An award recommendation usually begins at the Soldier's immediate chain of command. A commander or supervisor identifies an act of heroism or meritorious service that warrants recognition.
2. **Documentation:** The recommending party completes a DA Form 638 (Recommendation for Award). This form requires a

detailed description of the act, including dates, locations, and the specific impact of the Soldier's actions. The regulation provides specific language requirements for different levels of awards.

3. **Approval Authority:** Not all commanders have the authority to approve all awards. The regulation specifies which level of command can approve each decoration. For instance, a battalion commander may approve an Army Commendation Medal, but a general officer must approve a Legion of Merit. This tiered system ensures high-level oversight for the most prestigious honors.
4. **Review and Posting:** Once approved, the award is entered

into the Soldier's official records. The regulation includes strict time limits for processing awards to prevent delays that diminish the significance of the recognition.

### **COMMON MISTAKES AND HOW TO AVOID THEM**

---

Despite the clarity of the **US Army Awards and Decorations Regulation**, mistakes happen. Understanding common pitfalls can help Soldiers and leaders avoid them.

## **Wearing**

## **Unauthorized Awards**

A critical rule in the regulation is that a Soldier cannot wear a decoration they have not been formally awarded. This includes state awards, foreign awards, and unofficial commemorative ribbons. The regulation provides a strict list of authorized awards. Wearing a ribbon from a private company or a non-official organization is a violation of the regulation and can lead to corrective action.

# Incorrect Ribbon Configuration of the Same Decoration

Another frequent mistake is the incorrect stacking or sequencing of ribbons. For example, placing a service medal before a personal decoration. The only correct way to verify the order is to consult the precedence chart in AR 600-8-22 or use official online tools provided by the Army.

The regulation has specific rules for how to show multiple awards of the same medal. For instance, a second award of the Army Commendation Medal is denoted by an oak leaf cluster, not a second medal. The regulation explains the specific devices (oak leaf clusters, stars, numerals) used to denote subsequent awards.
