UNDERSTANDING THE FRUIT OF THE POISONED TREE DOCTRINE IN CRIMINAL LAW

Under this arrangement, federal prosecutors could use evidence illegally obtained by state law enforcement officers, as long as federal officers had not participated in the illegal conduct. Good Faith Exception

Although originally developed in the context of the exclusionary rule rather than the **Fruit of a Poisoned Tree**

doctrine itself, the good faith exception has important implications. Under *United States v. Leon* (1984), evidence obtained by police acting in reasonable reliance on a search warrant that is later found to be invalid may still be admissible.
