## Key Changes in 2020 That Affected Ophthalmology Coding

The year 2020 brought several updates that directly impacted ophthalmology coding. Understanding these changes is critical for anyone seeking to use an effective cheat sheet.

- **ICD-10-CM Updates:** The 2020 diagnosis code set included new codes for diabetic retinopathy, glaucoma, and age-related macular degeneration (AMD). For example, the code for mild nonproliferative diabetic retinopathy with macular edema was refined to require laterality and severity.
- **CPT Code Changes:** The AMA introduced new category III codes for emerging technologies such as ocular telemedicine and advanced

imaging. Additionally, several cataracts and retina surgery codes were revised to better reflect procedural complexity.

- **E/M Documentation Guidelines:**

Although the major E/M overhaul took effect in 2021, the 2020 guidelines still emphasized medical decision-making (MDM) and time. Coders needed to pay close attention to the level of history and exam required for each visit type.

- **Modifier 25 and Modifier 59:**

CMS clarified the use of modifier 25 for significant, separately identifiable E/M services on the same day as a procedure. The cheat sheet highlighted common scenarios in ophthalmology where these modifiers apply, such as a comprehensive exam prior to cataract surgery.

## ESSENTIAL SECTIONS OF THE 2020 OPHTHALMOLOGY CODING CHEAT SHEET

---

A well-designed cheat sheet organizes codes by service type. Below are the key categories that every ophthalmology coder needed to master in 2020.

## Evaluation and Management (E/M) Codes

Ophthalmologists often provide comprehensive eye exams for new and established patients. The 2020 cheat sheet included the most frequently used E/M codes:

- **New Patient:** 99201–99205 (level

1–5)

- **Established Patient:**

99211–99215 (level 1–5)

- **Consultations:** 99241–99245

(office/outpatient), 99251–99255

(inpatient)

The cheat sheet also listed the key components—history, exam, and MDM—required for each level. For example, a level 3 established patient visit (99213) typically involves a problem-focused history, expanded problem-focused exam, and low-complexity MDM. Coders were reminded to document the reason for the encounter, exam findings, and medical decision-making steps clearly.

## Common Ophthalmology Procedures (CPT Codes)

The cheat sheet included a quick-reference table of the most frequently performed eye procedures. Here are some of the essential codes from 2020:

- **Cataract Surgery:** 66984 (extracapsular cataract removal with IOL insertion, one stage), 66982 (complex cataract surgery), 66820–66852 (secondary lens procedures)
- **Retina and Vitreous:** 67028 (intravitreal injection of pharmacologic agent, e.g., anti-VEGF), 67036 (vitrectomy, pars plana), 67113 (repair of retinal detachment with vitrectomy)
- **Glaucoma:** 65855

(trabeculoplasty by laser surgery), 66711 (trabeculectomy), 66170 (trabeculectomy with drainage device)

- **Diagnostic and Special Tests:** 92012 (ophthalmological exam, established patient), 92014 (comprehensive exam), 92133 (scanning computerized ophthalmic diagnostic imaging, optic nerve), 92250 (fundus photography)

## Modifiers for Ophthalmology Claims

Modifiers play a vital role in communicating the specifics of a procedure to payers. The 2020 cheat sheet included a list of modifiers commonly used in ophthalmology:

- **-25:** Significant, separately identifiable E/M service by the same physician on the same day of a procedure (e.g., cataract consultation and subsequent surgery on the same visit).
- **-59:** Distinct procedural service (used when two procedures are performed in different anatomic sites or separate encounters, such as a retinal laser in the right eye and an injection in the left eye).
- **-LT / -RT:** Left eye/right eye – essential for bilateral procedures.
- **-50:** Bilateral procedure (e.g., cataract surgery on both eyes during the same operative session; note that payer rules vary).
- **-79:** Unrelated procedure or service by the same physician

during the postoperative period (e.g., a new problem not related to the prior surgery).

## ICD-10 Diagnosis Codes for 2020

Accurate diagnosis coding is the foundation of a clean claim. The cheat sheet highlighted the most common ophthalmology diagnoses updated in 2020:

- **Diabetic Retinopathy:** E08.31-E08.37 (diabetes mellitus due to underlying condition with diabetic retinopathy), E10.31-E10.37, E11.31-E11.37 (type 2 diabetes with retinopathy). Note the addition of codes for macular edema and proliferative retinopathy with specific laterality.
- **Glaucoma:** H40.11-H40.13 (primary open-angle glaucoma, staged), H40.20-H40.22 (primary angle-closure glaucoma), H40.30-H40.33 (pigmentary glaucoma).
- **Age-Related Macular Degeneration:** H35.30-H35.33 (nonexudative AMD), H35.35 (exudative AMD).
- **Cataract:** H25.0-H25.9 (age-related cataract, with or without laterality), including H25.01 (cortical age-related cataract, right eye) and H25.02 (left eye).
- **Dry Eye Syndrome:** H04.12 (dry eye syndrome, unspecified), with laterality codes (H04.121 right, H04.122 left, H04.123 bilateral).

### HOW TO USE THE CHEAT SHEET FOR DAILY CODING

Having the cheat sheet is only half the

battle. To maximize its value, coders and physicians should integrate it into their workflow. Here are practical tips for leveraging the **ophthalmology coding cheat sheet 2020** effectively:

## 1. Cross-Reference Diagnosis and Procedure Codes

Before submitting a claim, verify that the diagnosis code supports the medical necessity of the procedure. For example, an intravitreal injection (67028) should be linked to a diagnosis of wet AMD (H35.35) or diabetic macular edema (E11.311). The cheat sheet can help identify the correct pairings.

## 2. Use Modifiers Correctly

One common denial reason is improper use of modifier 25. The cheat sheet reminds coders that modifier 25 is only appropriate when the E/M service is separate from the procedure and the documentation includes a distinct history, exam, and medical decision. For instance, when a patient comes in for a glaucoma evaluation and later the same day undergoes a laser trabeculoplasty, you would bill the E/M with modifier 25 and the laser procedure separately.

## 3. Document

## Laterality and Severity

ICD-10 requires laterality (right, left, bilateral) and often severity staging. The 2020 cheat sheet included a reminder to check for codes ending in 1 (right), 2 (left), or 3 (bilateral). For diabetic retinopathy, use the specific code for mild, moderate, severe nonproliferative, or proliferative retinopathy.

## 4. Stay Updated on Medicare National Coverage Determinations

Medicare LCDs/NCDs for ophthalmology procedures—such as cataract surgery timing, frequency of intravitreal injections, and dry eye testing—change periodically. While the cheat sheet may summarize common rules, coders should always verify current local coverage policies.

### COMMON CODING PITFALLS IN OPHTHALMOLOGY AND HOW THE CHEAT SHEET HELPS

---

Even with a cheat sheet, mistakes can happen. Being aware of the most frequent errors can prevent costly denials.

## Pitfall 1: Billing a Comprehensive Exam (92014) When Documentation Only Supports a Limited Exam

Code 92014 requires a comprehensive history and exam with ophthalmological evaluation. Many practices overuse this code. The cheat sheet encourages coders to review the documentation for seven key elements of a comprehensive ophthalmic exam (e.g., external exam, slit lamp, dilated fundus exam) before choosing this code.

## Pitfall 2: Unbundling of Diagnostic Tests

Some payers consider certain tests—like visual field (92081-92083) and scanning computerized ophthalmic imaging (92133)—as inclusive of the E/M service if performed as part of the same visit. The cheat sheet reminds coders to check for National Correct Coding Initiative (NCCI) edits and bundle status.

## Pitfall 3: Incorrect Use of Modifier 50 for Bilateral Procedures

For procedures like cataract surgery, some payers require modifier 50 for bilateral, while others want two lines with modifiers LT and RT. The cheat sheet lists payer preferences and emphasizes verifying with each carrier.

## Pitfall 4: Missing Laterality in Diagnosis Codes

A claim for a retinal detachment repair (67113) with a diagnosis of H33.0X (retinal detachment with retinal break) that lacks laterality will be rejected. The cheat sheet reminds coders to use H33.001 (right eye), H33.002 (left eye), or H33.003 (bilateral).
