Energizing Breakfast : Savory Spinach and Feta Oatmeal

Oatmeal is a classic low GI breakfast, but it becomes truly exceptional when prepared with savory ingredients. This recipe is packed with protein and iron to start your day right.

Ingredients:

- 1/2 cup steel-cut oats
- 1 1/2 cups water or low-sodium

- vegetable broth
- 2 cups fresh spinach, roughly chopped
- 1/4 cup crumbled feta cheese
- 1 tablespoon olive oil
- 1 clove garlic, minced
- Salt and black pepper to taste
- Optional: One poached egg on top

Instructions:

1. In a medium saucepan, bring the water or broth to a boil. Add the steel-cut oats, reduce heat to low, and simmer for about 20-25 minutes, stirring occasionally, until tender and creamy.
2. While the oats cook, heat the

olive oil in a separate skillet over medium heat. Add the minced garlic and cook for 30 seconds until fragrant.

4. Once the oats are done, stir in the wilted spinach and half of the feta cheese.

1. In a large bowl, combine the cooked quinoa, chickpeas, cucumber, cherry tomatoes, red onion, and olives.
2. In a small jar or bowl, whisk together all the dressing ingredients until well emulsified.
3. Pour the dressing over the salad and toss gently to combine.
4. Fold in the crumbled feta cheese if using. Serve immediately or refrigerate for at least 30 minutes to allow the

Instructions:

1. In a large pot or Dutch oven, heat the olive oil over medium heat. Add the onion, carrots, and celery, and sauté for 5-7 minutes until softened.
2. Add the minced garlic and cook for one more minute.
3. Stir in the lentils, crushed tomatoes, vegetable broth, basil, and oregano. Bring to a simmer.
4. Reduce the heat to low, cover, and let it cook for 30-40 minutes, or until the lentils are tender but not mushy. Season with salt and pepper.
5. While the sauce simmers, spiralize the zucchinis. If you prefer a softer texture, you can briefly sauté the zucchini noodles in a dry non-stick pan for 1-2 minutes, or serve them raw for a crunchy twist.
6. Serve the lentil Bolognese generously over the zucchini noodles, garnished with fresh herbs. This

Wholesome Snack: Apple Slices with Almond Butter and Chia
