### NORMAL SCIENCE: PUZZLE-SOLVING WITHIN A PARADIGM

The majority of a scientist’s career occurs during periods of **normal science**. Armed with a paradigm, researchers engage in what Kuhn called “mopping-up operations.” They refine concepts, extend experimental results, and solve puzzles whose answers are already known to be possible within the paradigm. The goal is not to discover novel phenomena but to articulate and extend the paradigm’s range. Normal science is highly productive and cumulative, but it is also inherently conservative. Scientists are trained to work within the paradigm, not to challenge it.

This puzzle-solving nature explains why science can appear to be a straightforward accumulation of knowledge. However, Kuhn noted that normal science inevitably encounters anomalies—results that violate expectations set by the paradigm. At first, these anomalies are ignored or explained away. But as anomalies accumulate, a sense of crisis begins to grow.

### CRISIS: THE PRELUDE TO REVOLUTION

When anomalies persist and resist resolution, the scientific community enters a period of **crisis**. During this phase, confidence in the paradigm

erodes. Scientists start questioning foundational assumptions. Alternative approaches, previously dismissed, are revived or developed. The field becomes fragmented and philosophically introspective. Kuhn pointed to the example of pre-Copernican astronomy, where increasing inaccuracies in predicting planetary positions led to ad hoc modifications of Ptolemaic system. Such patchwork solutions could not sustain the paradigm indefinitely.

Crisis is uncomfortable but also fertile. It loosens the grip of tradition and opens the door for revolutionary thinking. However, Kuhn emphasized that crises are not easily resolved. Many scientists cling to the old paradigm, hoping to salvage it. Only when a new, compelling alternative emerges does the crisis turn into a full-blown revolution.

### SCIENTIFIC REVOLUTIONS: A CHANGE OF WORLDVIEW

A **scientific revolution** occurs when a new paradigm replaces an old one. This is not a simple adjustment but a fundamental reorientation. Kuhn used a powerful analogy: a revolution is like a **gestalt switch**, where the same data suddenly appears in a completely new pattern. For example, after Copernicus, the Earth was no longer the center of the universe; it moved around the Sun. This changed not only astronomy but also physics, philosophy, and even religion.

Kuhn argued that revolutions are not entirely rational in the classic sense. There is no neutral, algorithmic way to compare two paradigms. They are **incommensurable**—meaning there is no common measure to decisively judge one as superior. Standards of evidence, key concepts, and even the meaning of terms shift between paradigms. Proponents of the old and new paradigms often talk past each other. Conversion, not logical proof, is what ultimately resolves a revolution. This controversial claim struck at the heart of positivist philosophies of science, which saw scientific change as a purely logical process.

## Historical Examples Illustrating Kuhn’s Model

Kuhn’s book is rich with historical case studies. Three major examples stand out:

- **The Copernican Revolution:** The shift from a geocentric (Earth-centered) to a heliocentric (Sun-centered) universe. This revolution that took over a century to complete involved not just a new astronomy but a new physics, ultimately leading to Newton’s synthesis.
- **The Chemical Revolution:** The replacement of the phlogiston theory by Lavoisier’s oxygen theory. Before Lavoisier, combustion was explained by the release of phlogiston. Afterward, it was understood as the combination of a substance with oxygen. The very concept of a “chemical element” changed.
- **The Einsteinian Revolution:** The emergence of relativity and quantum mechanics challenged the Newtonian paradigm. While Newtonian physics remained useful for many everyday scenarios, it was no longer the ultimate framework for understanding space, time, and matter at extreme scales.

Each revolution followed the pattern: paradigm, normal science, anomalies, crisis, new paradigm, and conversion. Kuhn stressed that revolutions are not frequent—they are the exception, not the rule. But when they occur, they transform science.

## Incommensurability and the Problem of Progress

One of the most debated aspects of Kuhn’s work is the idea of **incommensurability**. If paradigms cannot be objectively compared, how can we say science makes progress? Kuhn himself struggled with this question. He ultimately argued that science does progress, but not toward a single, ultimate truth. Instead, progress is measured by the increase in a paradigm’s ability to solve puzzles, and by the consensus it generates within a community. After a revolution, the new paradigm is more effective at solving the problems that initiated the crisis. But from an outside perspective, the new paradigm is not necessarily “truer” in an absolute sense.

This relativistic flavor led to both praise and criticism. Critics accused Kuhn of undermining the objectivity of science. Defenders argued that his account is more descriptively accurate—science is a human activity, shaped by social and historical forces. Kuhn’s work opened the door to the sociology of scientific knowledge, influencing scholars like Bruno Latour and Steven Shapin.

## Impact Beyond the Philosophy of Science

*The Structure of Scientific Revolutions* reached far beyond its original discipline. The phrase “paradigm shift” entered the popular lexicon, used in business, education, and politics to describe any major change in thinking. Kuhn’s analysis of how communities adopt new frameworks resonated with management theorists, sociologists, and even artists. While many uses diluted the original meaning, they testify to the book’s conceptual power.

In the field of science studies, Kuhn’s work spurred new research into scientific practice. Historians began looking at the day-to-day work of scientists, the role of instruments, laboratory life, and the negotiation of credibility. Philosophers like Paul Feyerabend pushed Kuhn’s ideas further, arguing for

an even more anarchistic view of science. Meanwhile, some scientists themselves found Kuhn’s description unsettling but ultimately liberating—it acknowledged the difficulty of revolutionary thinking and the human element in discovery.

## Criticisms and Ongoing Debates

No influential work goes unchallenged, and Kuhn’s book has faced several important critiques. Some philosophers, such as Karl Popper, rejected the notion that normal science is a good description of how science should be. Popper argued that science progresses through bold conjectures and ruthless falsification, not puzzle-solving. Others, like Imre Lakatos, sought to reconcile Kuhn’s historical insight with a rationalist methodology through the idea of “research programmes.”

Another criticism focuses on the vagueness of the term “paradigm.” Kuhn himself acknowledged this and later refined his concepts, distinguishing between “exemplars” (shared concrete problem-solutions) and “disciplinary matrices” (shared commitments). Yet the original book’s sweeping style contributed to its impact, even if it left some conceptual ambiguities.

Historians have also argued that the actual history of science is messier than Kuhn’s model implies. Revolutions are often not as sharp or community-wide as the book suggests. Some changes happen gradually, and multiple paradigms can coexist for extended periods. Nonetheless, the general pattern Kuhn described remains a powerful heuristic tool.

## The Relevance of Kuhn Today

In an age of interdisciplinary research, rapid technological change, and ongoing debates about scientific credibility, Kuhn’s insights are timelier than ever. As we face global challenges like climate change and pandemics, understanding how scientific consensus forms and shifts is crucial.
