Permits

Then register a "Doing Business As" name if you are operating under a name different from your own legal name. Depending on your industry and location, you may also need local business licenses, health permits, or professional certifications. A quick visit to your city or county website usually lists the requirements. Ignoring this step can result in fines or forced closure later, so invest the time upfront.

Open a Separate Business Bank Account

Mixing personal and business finances is one of the fastest ways to create accounting nightmares and jeopardize your liability protection. Open a dedicated checking account and obtain a business credit card. Use accounting software to track every expense and invoice from day one. This discipline makes tax season far less stressful and provides the financial clarity you need to make informed decisions. Many banks offer free business accounts for the first year, and tools like Wave or QuickBooks

Self-Employed are affordable for solo operators.

STEP THREE: BUILD A MINIMAL, FUNCTIONAL ONLINE PRESENCE

In today's digital-first world, your website is your storefront. But you do not need an elaborate, custom-designed site to start. **Starting Your Own Business For Dummies** advocates for a minimal viable website that clearly communicates who you are, what you offer, and how to buy or contact you. Build an Email List from Day One

Email marketing remains one of the highest-return channels available. Offer a lead magnet, such as a free checklist, guide, or discount code, in exchange for email addresses. Use a simple email

service provider like Mailchimp or ConvertKit to send a welcome sequence and regular updates. Nurture your list with valuable content and occasional offers. People buy from those they know, like, and trust, and email is the most direct way to build that relationship over time.

STEP FIVE: MANAGE YOUR FINANCES AND PLAN FOR GROWTH
