UNDERSTANDING THE FOUNDATION: THE KENTUCKY UNIFORM RESIDENTIAL LANDLORD AND TENANT ACT

The cornerstone of rental law in Kentucky is the Kentucky Uniform Residential Landlord and Tenant Act (KURLTA). This body of law, enacted to standardize and clarify the rights and duties of both parties, sets the ground rules for everything from rent collection to eviction

procedures. A core principle of this act is the implied warranty of habitability, which requires landlords to maintain rental properties in a safe and livable condition. Who Is Covered by KURLTA?

It is important to note that not all rental agreements in Kentucky fall under KURLTA. The act generally applies to

- Transient occupancy in hotels or motels (stays of less than 30 days).
- Rentals owned or operated by the federal or state government.
- Certain housing provided by educational institutions for students.
- Occupancy under a contract for the sale of a dwelling.

KEY RESPONSIBILITIES FOR LANDLORDS: BEYOND COLLECTING RENT

Landlords in Kentucky have a set of clear, non-negotiable duties that are fundamental to a healthy and legal rental relationship. These obligations are designed to protect the tenant's right to a safe and peaceful home.

The Warranty

One of the most critical concepts in the Kentucky Landlord Tenant Guide 2022 is the implied warranty of habitability. This means that a landlord is legally required to deliver and maintain the rental premises in a condition that is fit for human habitation. This includes a wide range of responsibilities, such as:

- **Maintaining**

structural components:

Ensuring the roof, walls, floors, and foundation are weatherproof and safe.

Providing essential services:

Supplying running water, hot water, and reasonable amounts of heat during cold weather (except where the tenant pays for utilities directly).

- **Maintaining plumbing and electrical systems:**

Keeping all plumbing fixtures, wiring, and electrical outlets in good and safe working order.

- **Ensuring sanitation:** Maintaining common areas in a clean and safe condition and providing necessary garbage receptacles.
- **Complying with building codes:** Adhering to all applicable state and local housing, health, and safety codes.

A landlord cannot waive this warranty of habitability in a lease agreement. If a property has a significant defect that makes it uninhabitable (like a lack of heat in winter or a broken sewer line), the tenant has specific legal remedies, including the right to terminate the lease or, in some cases, to withhold rent

after proper notification.

Security Deposits: Rules for Collection and Return

Security deposits are a frequent source of disputes between landlords and tenants. The Kentucky Landlord Tenant Guide 2022 outlines specific rules to help avoid these issues. Here is what you need to know:

- **No Limit on Amount:** Unlike some states, Kentucky does not place a

statutory limit on the amount a landlord can charge for a security deposit. However, it must be reasonable.

- **Return**
Timeline: A landlord must return the security deposit, or provide an itemized list of deductions, to the tenant within 60 days after the lease terminates and the tenant has vacated the property.
- **Permissible Deductions:** A landlord can deduct from the security deposit for unpaid rent, utility bills, or for damage to the unit beyond normal wear and tear. Normal

wear and tear, such as minor scuffs on walls or faded carpet, cannot be deducted.

- **Notice of Intent:** If a landlord intends to deduct from the deposit, they must provide the tenant with a written, itemized list of the deductions, including the nature and cost of the repairs.

For tenants, conducting a thorough move-in inspection, taking dated photos, and keeping a copy of the inspection form is the best way to protect your deposit. For landlords, meticulous record-keeping and clear communication about deductions are key.

Landlord Access to the Rental Unit

A tenant has the right to quiet enjoyment of their home. This means a landlord cannot simply enter the property at any time. Generally, a landlord must provide the tenant with at least two days' notice before entering the unit for non-emergency reasons, such as making repairs or conducting an inspection. The entry must also be at a reasonable time. Exceptions to this notice requirement

include true emergencies, such as a fire or a burst pipe, or when the tenant has given consent. It is common practice for a lease agreement to allow for entry to show the property to prospective tenants or buyers with reasonable notice.

KEY RESPONSIBILITIES FOR TENANTS: RESPECT AND CARE FOR THE PROPERTY

Tenants also carry significant legal responsibilities. A lease is a contract, and fulfilling these duties is essential for a positive rental experience and to avoid potential legal action, such as eviction.

Paying Rent on Time

Maintaining the Premises

The most fundamental obligation of a tenant is to pay rent in full and on time as specified in the lease agreement. If rent is not paid, the landlord has the legal right to terminate the lease and begin an eviction proceeding. Kentucky law does not require a landlord to offer a “grace period” for late rent, though many landlords include one in their lease. If a tenant pays late, the landlord may also charge a late fee, but only if the lease agreement specifically provides for one.

Tenants are responsible for keeping their rental unit clean and sanitary and for using all appliances and fixtures in a reasonable manner. This includes responsibilities like:

- Disposing of garbage in a clean and safe manner.
- Keeping the plumbing fixtures clean.
- Using electrical and plumbing fixtures properly.
- Not deliberately or negligently destroying, defacing, damaging, or

removing any part of the premises.

A tenant is generally not responsible for damage caused by normal wear and tear, but they are responsible for any damage they or their guests cause. If a major repair is needed due to the tenant's negligence (for example, a blocked toilet from flushing inappropriate items), the tenant may be liable for the repair cost.

Following Lease Rules and

Regulations

A tenant must comply with all obligations imposed by the landlord under the lease agreement, as long as those obligations are not illegal or in violation of KURLTA. This includes rules regarding pets, guests, noise, parking, and the use of common areas. Violating these rules can lead to a lease termination notice and, eventually, eviction.

THE EVICTION PROCESS IN KENTUCKY: A STEP-BY-STEP OVERVIEW

An eviction is a legal process to remove a tenant from a rental

property. It is critical for both landlords and tenants to understand that a landlord cannot use “self-help” methods to evict a tenant. This means a landlord cannot change the locks, shut off utilities, or physically remove a tenant or their belongings. An eviction must go through the court system. The Kentucky Landlord Tenant Guide 2022 for evictions largely follows these steps:

1. Notice to the Tenant

The first step is for the landlord to provide the tenant with a written notice. The type of notice depends on the

reason for the eviction.

- **Nonpayment of Rent:** The landlord must give the tenant a seven-day notice to pay rent or vacate. If the tenant pays the full amount of overdue rent within those seven days, the eviction process stops.
- **Lease Violation:** For violations of the lease other than nonpayment of rent (e.g., having a pet when not allowed, causing excessive noise), the landlord must give a 14-day notice to cure the violation or vacate. If the tenant fixes the problem within 14 days, the

eviction process stops. If the violation is one that cannot be cured (e.g., criminal activity), the landlord can give a 14-day unconditional quit notice, ordering the tenant to move out.

- **Month-to-Month Tenancy:** If a tenant is on a month-to-month lease, the landlord (or tenant) can terminate the tenancy by giving a 30-day written notice.

2. Filing

an Eviction Lawsuit

If the tenant does not comply with the notice (e.g., does not pay rent or move out), the landlord can then file a formal eviction lawsuit, known as a “forcible detainer” action, in the District Court of the county where the property is located.

3. Court Hearing and Judgment

The court will schedule a hearing. Both the landlord and tenant

have the right to present their case. If the judge rules in favor of the landlord, a judgment for possession (and possibly for money damages like unpaid rent and court costs) will be issued. The tenant will be ordered to vacate the property. In Kentucky, the tenant typically has 7 days from the date of the judgment to move out.

4. The Writ of Possession

If the tenant does not move out by the court-ordered date, the landlord can request a “writ of possession” from the court. This

document authorizes the local sheriff or constable to physically remove the tenant and their belongings from the property. This is the final step in the eviction process. The tenant will be responsible for the cost of the writ being served.

FAIR HOUSING LAWS IN KENTUCKY

Both federal and state fair housing laws protect tenants from discrimination. Under the Fair Housing Act, it is illegal for a landlord to discriminate against a tenant or prospective tenant based on:

- Race
- Color
- National origin
- Religion
- Sex (including sexual

orientation and gender identity)

- Familial status (having children under 18, being pregnant)
- Disability (physical or mental)

This means a landlord cannot refuse to rent to someone, set different terms or conditions, or advertise a preference based on these protected classes. Landlords are also required to make reasonable accommodations for tenants with disabilities, such as allowing a service animal even in a "no pets" building. Any tenant who believes they have been a victim of housing discrimination can file a complaint with the U.S. Department of Housing and Urban

Development (HUD) or the Kentucky Commission on Human Rights.

SPECIAL CONSIDERATIONS FOR THE 2022 KENTUCKY RENTAL MARKET

The context of 2022 brought specific challenges and considerations to the rental market. Economic factors, including inflation and shifting housing demands, meant that both landlords and tenants needed to be especially vigilant.
