## TRICK ONE: THE UTILITY VERIFICATION CALL

A tracer might knock on a neighbor's door and say, "I have a misdelivered package for an apartment 2B. Is that you?" Even if the neighbor says no, they often volunteer information. lives there anymore. The guy moved out last month." This casual exchange reveals a wealth of information without raising suspicion. This technique is a staple in any course on how to learn skip tracing at an advanced level.

### **TRICK THREE: THE "FORGOTTEN PASSWORD" CLUE**

TinEye. You might discover that same photo is used on a forgotten profile on a niche forum, a dating site, or a professional networking site. That profile might list a city or even a current employer. This is one of the skip trace secrets that requires no special software, just a keen eye and patience.

Experienced skip tracers understand criminal psychology. A subject who is

hiding often behaves predictably. They use aliases, but they usually stick to a pattern. For example, a man named "John Michael Smith" might use "Mike Smith" or "John Michaels." He rarely chooses a completely random name. Additionally, if a skip is on the run, they will often contact someone they trust, such as a mother, a sibling, or a former spouse. Monitoring public records connected to these associates is a classic trick. If the mother suddenly has a new phone number in a different state, the subject might be nearby. ## Advanced Phone Number Techniques

Credit header data includes name, date of birth, Social Security Number (partial), and past addresses. This information is available through licensed skip tracing databases. the header. The skip tracer can then search for that associate to find the subject. This is a powerful method because it leverages the financial connections that most people forget about. ## Email Address Forensics
