UNDERSTANDING DISSOLUTION OF MARRIAGE IN OHIO

Residency Requirements

THE CORE DOCUMENT: SEPARATION AGREEMENT

The foundation of any Ohio dissolution is a legally binding document called a separation agreement. This agreement must address every aspect of your marital life that requires legal resolution. Drafting a thorough and precise separation agreement is the single most important step in the entire process.

Essential Elements

of a Separatio n Agreeme nt

- **Division of property:** List all marital assets and debts, including real estate, vehicles, bank accounts, retirement accounts, investments, credit card balances, and loans. Specify who receives each asset and who is responsible for each debt.
- **Spousal support**

(alimony):

- **Tax implications:** Determine how tax refunds or liabilities will be

allocated and who will claim dependents for tax purposes.

- **Parenting plan (if applicable):**

Include a detailed schedule for parenting time, decision-making authority, holidays, vacations, and methods for resolving future disputes.

- **Child support:**

Calculate child support according to Ohio's child support guidelines. The court must approve any deviation from the standard calculation.

Drafting the Separation Agreement

While it is possible to draft a separation agreement without an attorney, it is generally not recommended unless your situation is very simple and you both fully understand the legal consequences. A lawyer can help ensure the agreement is enforceable, complete, and fair. Many couples choose to hire a mediator or collaborative attorney to facilitate

negotiations. Once the agreement is finalized, both spouses must sign it voluntarily, and their signatures must be notarized.

STEP-BY-STEP PROCESS: HOW TO GET A DISSOLUTION OF MARRIAGE IN OHIO

Step 1: Prepare and File

How Long Does a Dissolution Take?

In practice, most dissolutions are finalized within 6 to 12 weeks, depending on court scheduling and how quickly you complete the paperwork.
