The primary coil receives the oscillating signal and creates a changing magnetic field. This field induces a much higher voltage in the secondary coil. The ratio of turns between the coils determines the voltage multiplication. A typical ratio might be 1:100 or even higher.

## Multiplier (Optional)

Some designs use a Cockcroft-Walton multiplier, a ladder network of diodes and capacitors, to further increase the voltage from the transformer to even higher levels. This is where voltages in the range of 50,000 volts or more are achieved.

## The Discharge Circuit

High-voltage capacitors store the energy. When the trigger is pressed, a switch (often a spark gap or a semiconductor switch)

rapidly discharges the stored energy through the output electrodes or wires. The repetitive charging and discharging cycle creates the characteristic pulsing effect.

## THE STEP-BY-STEP THEORETICAL PROCESS

---

When the capacitor voltage exceeds the breakdown voltage of the spark gap, it discharges through the electrodes.

6. **Enclose the Device:** Use an insulating material like ABS plastic. All high-voltage points must be isolated. A safety interlock or trigger guard prevents accidental activation.

Each of these stages carries significant risk



of electric shock, component damage, or fire. This is why commercial manufacturers invest heavily in testing and quality control.
