## CPT: Procedure Coding

The Current Procedural Terminology (CPT) code set, maintained by the American Medical Association (AMA), covers medical, surgical, and diagnostic services. Spend significant time working through surgical scenarios. Practice coding everything from a simple lesion removal to a complex spinal fusion. The more you practice, the faster and more accurate you will become.

## HCPCS Level II: Supplies and Services

The Healthcare Common Procedure Coding System (HCPCS) Level II covers items and services not included in CPT, such as durable medical equipment, prosthetics, orthotics, supplies, and certain drugs and biologicals. Your **Medical Billing And Coding Exam Study Guide** should include common HCPCS Level II codes and modifiers. Pay attention to:

- The difference between **J codes** (drugs administered other than oral) and **E codes** (durable medical equipment).
- **K codes** for temporary codes for Medicare and **G codes** for professional services.
- **HCPCS Level II modifiers** like **LT** and **RT** for left and right, as well as the unique modifiers for ambulance services and rental equipment.

While HCPCS Level II may seem less prominent than CPT or ICD-10-CM, it represents a significant portion of the exam and is critical for real-world billing, especially in outpatient and DME settings.
