## Chemical Potential and Equilibrium Conditions

The condition for equilibrium across phases is that the chemical potential ( $\mu$ ) of each component must be equal in all phases. For a pure substance,  $\mu$  is simply the molar Gibbs free energy. For mixtures,  $\mu$  depends on composition. ## Equilibrium States
