- **Official Misconduct and Penalties:** What constitutes a violation of your notary duties? The consequences for misconduct can include fines, revocation of your commission, and even criminal charges. This section is frequently tested.

# Building Your Speed Study Plan

- **The Notary Fee Schedule:** Charging an oath (\$2), an acknowledgment (\$2), a protest (\$2), and a certificate of protest (\$2) are common fees. Also, know

the fees for services like administering an oath to a person not in your presence (which is generally not allowed). Memorize the fee for a certificate of a notarial act (\$2).

- **The Prohibited Acts:** A notary cannot: (a) certify copies of documents that are not in the notary's custody or that do not fall under specific exceptions, (b) notarize their own signature, (c) act in a transaction where they have a personal interest, or (d) practice law. These are golden rules.
- **The Acknowledgment vs. Jurat:** An acknowledgment is when the signer personally appears before you and acknowledges that they signed the document voluntarily. A jurat is when the signer swears or affirms the truthfulness of the contents of the document in your presence. The key difference is the oath or affirmation.

### PHASE 3: ACTIVE PRACTICE TESTING (DAY 5-6)

This is the most critical phase of any effective **New York Notary Public Exam Speed Study Guide**. Find as many free practice tests online as you can. ## APPEARANCE"

This rule is ironclad. A notary must have the signer physically present before them. You cannot notarize a document for someone who is on a video call, who sends it by mail, or who has someone else bring it. The only exception is for certain remote notarization laws that are very specific and limited in New York. The default rule is personal appearance. The exam loves to test this with tricky scenarios.

## CONFUSING "CERTIFIED COPIES"

Many people mistakenly think notaries can certify copies of any document, like a birth certificate or a passport. In New York, a notary can only certify a copy of a document that is in their custody and for which they have the original. Even then, there are nuances. The general rule is that notaries do not make certified copies. This is a common trap question.

## IGNORING THE "INTERESTED PARTY" RULE

A notary cannot notarize a document if they are a party to the transaction or if they will directly benefit financially from it. This includes notarizing for a spouse or business partner in many cases. The test often presents scenarios involving family members or colleagues to see if you recognize a conflict of interest.

# Final Test-Taking Tips for Speed

## and Accuracy

The exam is timed, so efficient test-taking is part of the challenge. Here are a few strategies to incorporate into your **New York Notary Public Exam Speed Study Guide**:

1. **Read the Question First:** Before you look at the answer choices, read the question carefully. Underline key words: "NOT," "EXCEPT," "always," "never," "best." These words dramatically change the meaning.
