The screen resolution for iPhone 5 is **1136 x 640 pixels**. This was a significant departure from the 960 x 640

resolution of the iPhone 4 and 4S, representing a 176-pixel increase in height while maintaining the same width. The result was a display that measured 4 inches diagonally, with an aspect ratio of 16:9—the same widescreen format used in HDTV and cinema.

This specific resolution was not chosen arbitrarily. Apple's engineers calculated that 1136 pixels of height, combined with the existing 640-pixel width, would allow for a seamless scaling of existing apps while providing enough additional vertical space to enhance browsing, reading, and video playback. The pixel density remained at a crisp **326 pixels per inch (PPI)**, which Apple branded as "Retina Display"—a term indicating that the human eye could not discern individual pixels at a typical viewing distance.

Why 1136 x 640? The Engineering Behind the Choice

The decision to increase only the height of the display—rather than both dimensions—was a masterstroke of practical engineering. By keeping the width at 640 pixels, Apple ensured that existing iPhone apps designed for the 3.5-inch screen could run in letterboxed mode without distortion. Apps that were

not updated for the new resolution would simply display with black bars at the top and bottom, preserving the original layout and functionality.

This backward compatibility was crucial for maintaining the user experience during the transition. Developers were encouraged to adopt the new screen resolution for iPhone 5 by using Auto Layout and spring-and-struts positioning, which allowed interface elements to dynamically adjust to the taller display. The result was a smooth migration that avoided the fragmentation seen in other mobile ecosystems.

**RETINA DISPLAY TECHNOLOGY:
MORE THAN JUST PIXELS**

The screen resolution for iPhone 5 was delivered through Apple's second-generation Retina Display technology. While the pixel count was important, the real magic lay in how those pixels were implemented. The display used an **IPS (In-Plane Switching) LCD panel** that offered exceptional color accuracy, wide viewing angles, and excellent contrast ratios.

Key technical specifications of the iPhone 5 display include:

everything from reading text to editing photos.

The Retina Display Threshold: Why 326 PPI Was Enough

Apple's claim that 326 PPI was beyond the limits of human vision was based on scientific research into visual acuity. At a typical viewing distance of 12 to 14 inches, the human eye cannot resolve detail finer than approximately 300 PPI. By targeting 326 PPI, the screen resolution for iPhone 5 ensured that text appeared as sharp as printed material, with no visible pixelation or aliasing.

This threshold became a benchmark for the entire smartphone industry, forcing competitors to race toward higher pixel densities. Today, many flagship phones exceed 400 or even 500 PPI, but the iPhone 5's display remains remarkably crisp for everyday use—a testament to the forward-thinking design of its resolution.

HOW THE SCREEN RESOLUTION FOR IPHONE 5 COMPARED TO ITS PREDECESSORS

To fully appreciate the significance of the iPhone 5 display, it is helpful to compare it with earlier iPhone models:

IMPACT ON APP DEVELOPMENT AND USER INTERFACE DESIGN

The introduction of the screen resolution for iPhone 5 created both opportunities and challenges for app developers. Apple provided clear guidelines for adapting apps to the new display, but the transition required careful attention to layout and asset scaling.

Auto Layout and Adaptive Interfaces

The iPhone 5 continued Apple's use of @2x assets for Retina Display graphics. Developers were required to provide two sets of images: standard resolution (1x) for older devices and double resolution (2x) for Retina displays. With the introduction of the iPhone 5, developers also had to ensure that their background images and full-screen graphics were designed to fill the 1136-pixel height without distortion or cropping.

Apple recommended using **PNG images with transparency** for icons and UI elements, and **JPEG images** for photographic backgrounds. The larger screen also prompted many developers to rethink their information architecture, using the extra vertical space to display additional content or controls directly on screen rather than behind menu buttons.

LEGACY AND INFLUENCE: WHAT THE IPHONE 5 RESOLUTION MEANT FOR FUTURE IPHONES

The screen resolution for iPhone 5 established a design language that persisted through several subsequent iPhone generations. The 16:9 aspect ratio became the standard for all iPhones

from the iPhone 5 through the iPhone 8 Plus, including the iPhone 6, 6 Plus, 7, and 7 Plus models. Even when Apple introduced larger displays with higher resolutions, the core principle of maintaining a consistent pixel density and aspect ratio remained unchanged.

The iPhone 5's resolution also influenced the development of the iPhone 5C and iPhone 5S, both of which used the same 1136 x 640 display. This consistency made it easier for developers to support multiple devices without additional optimization work, and it ensured that users had a uniform visual experience across the lineup.

From 1136 x 640 to 2436 x 1125: The Evolution Continues

With the iPhone X in 2017, Apple moved to an OLED display with a resolution of 2436 x 1125 pixels (458 PPI) and a new 19.5:9 aspect ratio. While this was a dramatic leap in both pixel count and technology, the fundamental design principles established with the iPhone 5—adaptive layouts, Retina-level pixel density, and careful attention to color accuracy—remained central to Apple's display philosophy.

Today, the iPhone 14 Pro Max features a resolution of 2796 x 1290 pixels (460 PPI) with ProMotion technology and a 120Hz refresh rate. Yet the legacy of the iPhone 5's screen resolution endures: it was the first time Apple demonstrated that a taller display could enhance usability without sacrificing sharpness or

color quality.

PRACTICAL CONSIDERATIONS FOR USERS AND COLLECTORS

For those who still use an iPhone 5 or are considering purchasing one as a secondary device or collector's item, the screen resolution remains highly functional for basic tasks. The 1136 x 640 display is perfectly adequate for:
