THE PATH TO BECOMING A REGISTERED DIETITIAN

Education al Requirem ents

To become a Registered Dietitian, you must earn at least

a bachelor's degree from a program accredited by the Accreditation Council for Education in Nutrition and Dietetics (ACEND). While a major in dietetics or nutrition is common, ACEND also allows for a pathway through a Didactic Program in Dietetics (DPD) that can be paired with another major. The degree coursework covers subjects such as biochemistry, physiology, food science, medical nutrition therapy, and management. Starting in 2024, the CDR has implemented a new requirement: by 2030, a graduate degree (master's) will be mandatory to sit for the registration exam. However, many students are already opting for a combined

bachelor's and master's route or a coordinated program that integrates both.

Supervised Practice (Dietetic Internship)

After completing the didactic coursework, aspiring RDs must participate in a supervised practice program—commonly called a dietetic internship. These programs are ACEND-accredited and typically last 8 to 12 months. During the internship, you complete at least 1,200 hours of supervised practice in

various settings: clinical nutrition, community nutrition, food service management, and sometimes specialty rotations. Many internships are competitive, requiring a strong GPA, relevant work experience, and compelling personal statements. Some coordinated programs combine the coursework and internship into one integrated curriculum, streamlining the process.

Passing the Registration Exam

Once you've earned your degree (or will

soon complete it) and finished the supervised practice, the next step is to pass the Commission on Dietetic Registration (CDR) exam. This computer-based test consists of 125 multiple-choice questions covering four domains: Principles of Dietetics, Nutrition Care for Individuals and Groups, Management of Food and Nutrition Services, and Foodservice Systems. The exam is rigorous and requires thorough preparation using study guides, review courses, and practice tests. After passing, you can use the title “Registered Dietitian” (or “Registered Dietitian Nutritionist”).

State Licensure and Certifications

In most U.S. states, you must also obtain a state license or certification to practice as a dietitian. Licensing requirements typically mirror the national RD credential, but you may need to submit an application, pay fees, and pass a state jurisprudence exam. Some states have additional continuing education mandates. It is essential to check with your state’s licensing board. Beyond state licensure, many RDs pursue

specialty certifications, such as Certified Diabetes Care and Education Specialist (CDCES), Board Certified Specialist in Sports Dietetics (CSSD), or Certified Specialist in Pediatric Nutrition (CSP). These advanced credentials can enhance your expertise and job prospects.

hours. A passing scaled score is 25 or higher.

Step 4: Obtain State Licensure (if required)

Contact your state's board of dietetics or health department. Provide proof of your RD credential and pay licensing fees. Some states require a background check. Once licensed, you can legally practice as a dietitian.

Step 5: Consider Advanced Degrees or Specializa tions

Although a master's degree will be mandatory after 2030, many RDs pursue a Master of Science in Nutrition or a related field to deepen expertise and qualify for faculty or research positions. Additional certifications in areas like renal nutrition, oncology nutrition, or integrative health can differentiate you in the

job market.

SKILLS AND QUALITIES OF A SUCCESSFUL REGISTERED DIETITIAN
