The driving evaluation typically includes:

- **Basic maneuvers:** Expect to demonstrate parallel parking, backing into a loading dock, and navigating narrow alleyways or tight turns.

- **Defensive driving:** The evaluator will observe your awareness of pedestrians, cyclists, and other vehicles, especially in congested areas common to SEPTA's operating environment.
