For the **Less Than Zero first edition**, the specific markers are clear, though subtle. Simon & Schuster published the book in May of 1985. The key identifier is the

- **Binding:** The first edition was bound in black cloth boards with silver lettering on the spine. The paper quality is also distinct, often feeling slightly heavier and more textured than later print runs.
- **Author Photo:** The back flap of the dust jacket features a black-and-white photo of Bret Easton

Ellis, looking very young, intense, and fashionable for the era.

THE MARKET VALUE AND COLLECTIBILITY

The value of a **Less Than Zero first edition** has appreciated significantly over the decades. While you might find a later printing in a used bookstore for a few dollars, a true first edition in fine condition is a serious investment.
