UNDERSTANDING THE WD AGO FORM 53 55 BLANK: A COMPLETE GUIDE FOR FEDERAL CONTRACTORS

If you are involved in federal or federally funded construction projects, you have likely encountered the requirement to submit specific payroll documentation. Among the most important documents are the WH-53 and WH-55 forms, often referred to collectively in project specifications as the

"Wd Ago Form 53 55 Blank." While the phrase may appear cryptic at first glance, it refers to the standard blank copies of these two official U.S. Department of Labor wage and hour forms. WHAT IS THE WD AGO FORM 53 55 BLANK?

The term "Wd Ago

Form 53 55 Blank" is a shorthand way of referring to the two primary payroll compliance forms used by the Wage and Hour Division (WHD) of the U.S. Department of Labor: **Form WH-53** (Statement of Compliance) and **Form WH-55** (Weekly Payroll Report). "Wd Ago" is likely a misreading of "WH" (Wage and Hour) or an abbreviation for "Wage and Hour Division Ago" - but in practice, contractors and compliance officers simply call them the WH-53 and WH-55 blank forms. These documents are essential for demonstrating that workers on Davis-Bacon Act covered projects receive prevailing wages and are paid correctly.

The Role of the Davis-Bacon Act

The Davis-Bacon Act requires that all laborers and mechanics employed on federal construction contracts exceeding \$2,000 be paid no less than the locally prevailing wages and fringe benefits as determined by the Department of Labor. To enforce this, contractors and subcontractors must submit certified payroll records each week. The WH-53 and WH-55 forms are the standard vehicles for that

certification. When someone searches for a "Wd Ago Form 53 55 Blank," they are typically looking for clean, unfilled templates of these two forms to print or fill out digitally.

BREAKING DOWN FORM WH-53 (STATEMENT OF COMPLIANCE)

Form WH-53 is the Statement of Compliance, often referred to as the "certification page." It serves as a sworn statement from the contractor that the attached payroll is accurate and that workers have been paid in accordance with the contract's wage determinations. The blank WH-53 form includes fields for:

- **Payroll period covered**
- **Contractor name and address**
- **Signature of the authorized company official**
- **Date of certification**

The form must be signed under penalty of perjury. The blank version (WH-53 blank) is often distributed along with the WH-55 payroll sheets. When contractors search for a "Wd Ago Form 53 55 Blank," they need both forms in their unfilled state because the WH-53 is the cover sheet that validates the detailed payroll data on the WH-55.

Common Errors When Filling Out WH-53

Even with a blank template, mistakes are common. Contractors sometimes leave off the contract number, forget to include the correct wage determination, or fail to sign the form. A blank WH-53 should be reviewed carefully. The "contract number" must match exactly what appears in the prime contract. The statement also includes a line confirming that no

deductions have been made that are not authorized. Using a blank WH-53 from an official government source reduces the chance of outdated fields.

BREAKING DOWN FORM WH-55 (WEEKLY PAYROLL REPORT)

Form WH-55 is the detailed weekly payroll report. It lists every employee working on the job site during that week, along with their classification, hours worked, hourly wage, fringe benefits paid, and deductions. The blank WH-55 form contains rows and columns for:

- **Employee Name and ID**
- **Labor Classification**
(e.g., carpenter,

laborer,
electrician)

- **Hourly Rate of Pay** (including fringe contributions)
- **Daily Hours Worked** (Monday through Sunday)
- **Total Weekly Hours**
- **Gross Pay**
- **Deductions** (taxes, insurance, etc.)
- **Net Pay**

The blank WH-55 form is designed to be filled in by hand or typed, and it is typically submitted as part of a PDF packet. When searching for a "Wd Ago Form 53 55 Blank," you are essentially looking for the full payroll packet. It is important to ensure the blank WH-55 you obtain is the most recent version, as the

WHD occasionally updates the layout.

Why Accurate Payroll Matters

Failure to submit accurate WH-53 and WH-55 forms can result in contract suspension, debarment from future federal work, or even criminal penalties if false statements are made. Therefore, using a reliable blank copy of these forms is not just a clerical step – it is a compliance necessity. Many contractors keep a stack of "Wd Ago Form 53 55 Blank" PDFs on hand for each pay period.

Where to Find Official Blank Template

HOW TO OBTAIN A BLANK WH-53 AND WH-55 FORM (WD AGO FORM 53 55 BLANK)

The official source for blank copies is the U.S. Department of Labor Wage and Hour Division website. You can download the forms in PDF format directly from the WHD forms page. However, many contractors search for "Wd Ago Form 53 55 Blank" and land on third-party sites that republish the forms. While these can be convenient, always verify that the blanks are identical to the official government version. Some third-party versions may contain outdated fields or be missing the OMB control number.

To avoid compliance issues, follow these steps:

1. Go to the U.S. Department of Labor, Wage and Hour Division website (dol.gov/whd).
2. Navigate to the "Forms" section.
3. Look for "WH-53" and "WH-55" under the Davis-Bacon and Related Acts category.

4. Click the link to open the PDF. Save a blank copy to your local drive.
5. Print or fill digitally as needed.

Alternatively, some contracting agencies, such as the General Services Administration (GSA) or state transportation departments, provide blank versions in their contract administration manuals. If your contract specifically mentions "Wd Ago Form 53 55 Blank," your contracting officer can also email you the approved template.

BEST PRACTICES FOR FILLING OUT WH-53 AND WH-55 FORMS

Once you have your blank copies, follow

these guidelines to ensure accurate and timely submission:

Use Consistent Employee Data

Each week, list the same employees in the same order to make audits easier. Ensure that the labor classifications match those in the wage determination exactly. For example, if the wage determination lists "Carpenter (Interior)" do not shorten it to just "Carpenter."

Calculate WH-53 Fringe Certificate Benefits

Correctly

The WH-55 has a column for "Hourly Rate of Pay Including Fringe." If you pay fringe benefits as cash in lieu, include that amount in the hourly rate. If you provide a bona fide fringe benefit (e.g., health insurance), note it separately or follow the instructions on the blank form. Incorrect fringe reporting is a top reason for payroll rejection.

The blank WH-53 must be signed by an authorized officer of the company. Electronic signatures are generally accepted if the contract permits. Never pre-sign blank forms – sign only after the WH-55 data is complete and verified.

No, the official names are WH-53 and WH-55. The phrase "Wd Ago Form 53 55 Blank" appears to be a typographical artifact or a casual shorthand used in some procurement documentation. Always use the official form numbers when communicating with your contracting officer.

Yes, many payroll software packages (e.g., LCPtracker, eMars, or Contractor Payroll) can produce WH-53 and WH-55 outputs that match the blank templates. However, you must verify that the software output is identical to the official blank format. Some agencies require the exact government PDF layout.

What happens if I submit a filled form that is not the official blank?

If the form deviates from the official "Wd Ago Form 53 55 Blank" version, the contracting officer may reject it as non-compliant. You could then receive a notice of non-compliance, which may delay payment or trigger a labor standards investigation.

DIGITAL VS. PAPER BLANK FORMS

While paper blank forms are still used on smaller projects, most federal primes now require electronic submission. The blank digital versions (fillable PDFs) are widely available. When you search for "Wd Ago Form 53 55 Blank," you typically want the digital fillable version. Be aware that some fillable PDFs from unofficial sources may not save all data correctly. Always test the blank form by entering sample data before using it for a real payroll period.

How to

CONSEQUENCES Fill Digital Blanks Correctly

Open the blank PDF in Adobe Acrobat or a compatible viewer. Use the "Prepare Form" tool if fields are not automatically highlighted. Enter data carefully, and double-check calculations. Save a copy for each pay period. If the form is locked, you may need to request an unlocked blank from the contracting officer. Some contractors prefer to print out a blank WH-53 and WH-55, fill them by hand, and scan them – this is still acceptable as long as the information is legible.

OF USING AN INCORRECT BLANK FORM

Using a generic or outdated "Wd Ago Form 53 55 Blank" from a random website can cause significant headaches. For example, if the blank form lacks a field for the wage determination number, the contracting officer will return the entire payroll. In severe cases, repeated submissions with wrong blanks can lead to a formal investigation by the WHD. Always confirm the version date on the blank form with the form version listed on the WHD website. The current versions are listed with OMB control numbers.

CONCLUSION

The phrase "Wd Ago Form 53 55 Blank" may seem like bureaucratic jargon, but it represents a critical compliance requirement for federal contractors. The WH-53 Statement of Compliance and the WH-55 Weekly Payroll Report must be submitted accurately and consistently to ensure workers receive their proper wages and to keep contracts in good standing. By

understanding the purpose of each form, obtaining official blank copies from reliable sources, and following best practices for completion, contractors can avoid penalties and maintain a reputation for regulatory compliance. Always treat the blank WH-53 and WH-55 as essential tools - not afterthoughts - in your payroll process, and you will navigate Davis-Bacon requirements with confidence.
